Memorandum of cooperation and partnership between

International Cultural-Educational Center, Georgia and

Ukrainian-Georgian Cultural and Educational Center of the Dnipro University of Technology, Ukraine

PART I – THE PARTIES OF THE MEMORANDUM

The International Cultural-Educational Center, Georgia, having the registered office in the Georgia, 0179, Tbilisi, 14, Kobuleti 1st Turn Str., in the person of the director and founder of the center, Irma Jangirashvili.

The Ukrainian-Georgian Cultural and Educational Center of the Dnipro University of Technology, Ukraine, having the registered office in the Ukraine 49005, Dnipro, 19, D. Yavornitsky Ave., in the person of the director of the center, Yuliia Dubiei.

The parties of the present Memorandum consider that they have common goals and interests, want to develop cooperation within the training programs and projects on self-development and personal growth, team work and cross-cultural dialogue, and in this regard have agreed to sign the present Memorandum of cooperation and partnership, hereinafter referred to as the "Memorandum", which provides the following:

PART II - GENERAL DIRECTIONS OF COOPERATION

Article 1. The memorandum is designed to promote and develop mutually advantageous exchange and cooperation. Both parties agree to promote exchange and cooperation between the organizations. In these joint programs of the organization will be guided by mutual interest in assistance to development of the training and cultural cooperation between the relevant institutions.

Article 2. Both parties announce bilateral cooperation between their relevant institutions, mainly, in the field of the educational and developing projects and actions present.

Article 3. The areas which are of mutual interest to cooperation include, but aren't limited to:

- · Mutual visits between senior administrators and other administrative personnel;
- · Exchange of experience of representatives in area of the international mobility;
- Development and implementation of joint projects in a context of national and international cooperation;
- The training programs and projects on self-development and personal growth;
- Organization of joint actions, tourist programs;

- Development of skills of team work and cross-cultural dialogue;
- · Participation in scout camps;
- · Passing of linguistic practice.

Article 4. Specific programs and joint actions are defined and coordinated by both institutions by stand-alone programs in which detailed conditions will be presented. Conditions of cooperation and the necessary budget for each program and actions and other details of these actions have to be discussed and be coordinated mutually in writing by both parties, prior to implementation of the specific program or activity. Programs and actions have to be agreed in due time. Both parties understand that all financial arrangements have to make a reservation separately and depend on existence of sources of financing. Financing details, including sources of financing and an obligation for financing have to be specified in appendices. Exchange of participants has to be approved by host beforehand.

Article 5. Each organization will appoint one (or more) person (persons), as required, for development and coordination of specific programs and actions, according to conditions of the present Memorandum.

Article 6. Information obtained from the joint activity which is carried out within the present Memorandum has to be available to all parties.

PART III - EXTENSION, THE TERMINATION AND CHANGE

Article 7. The present Memorandum remains in force within five (5) years from the date of the last signature, with understanding that this Memorandum can be terminated by mutual consent of the parties or one of the parties, in six months after the written notice of the other party at any time. In the absence of such notice, the Memorandum lasts for new term automatically by default. The present Memorandum can be changed by exchange of letters between two organizations. Any amendments or changes demand the written consent of authorized officers of each organization, and are attached to the present Memorandum. Such amendments, after approval by both organizations, become a part of this Memorandum. Any amendments, consent or refusal of conditions of the present Memorandum are obligatory for the parties if they are also signed in writing by all parties. Any such change, consent or refusal is valid only in a specific case and for specific goals.

The International Cultural-Educational Center and the Ukrainian-Georgian Cultural-Educational Center of the Dnipro University of Technology, signed by authorized representatives, confirm that they have read and have understood the present Memorandum and agree with its conditions.

In confirmation of the above, the present Memorandum is made by legally authorized representatives of the specified parties, in 6 identical copies, in English,

3 copies for each party and in 6 identical copies, in Russian, 3 copies for each party.
